The department is a model for team-based clinical education, where generalist and specialty faculty collaborate to ensure each graduate is practice-ready.

## The Role of the Chair

- Leads the daily operations of one of NYU Dentistry's largest departments (about 70 full-time and 160 part-time faculty), bringing proven administrative experience and the ability to run the complex operations of a large department.
- Manages the departmental budget and ensures fiscal responsibility while supporting academic and clinical priorities.
- Recruits, mentors, and manages faculty, fostering growth and professional development across all ranks.
- Directs a patient-centered clinical enterprise serving the entire DDS program and collaborates with clinical staff and administrators to improve efficiency and quality of clinical care.
- Creates and implements an innovative digital dentistry curriculum that prepares graduates for modern practice while aligning clinical training with evolving technology and standards of care.
- Fosters a culture that values creativity, collaboration, and continuous improvement.

## Candidate Qualifications

- Eligibility for appointment at the appropriate academic rank within NYU
- At least ten years of experience in academic dentistry with progressive leadership responsibilities, including a minimum of five years in administrative roles
- Documented record of teaching excellence, scholarly achievement, and creative integration of digital technology in education or clinical practice
- Proven success in strategic planning, curriculum innovation, and building high-performing teams
- Strong record of mentoring and inspiring faculty and students, with the ability to attract and develop emerging talent
- Demonstrated ability to lead large, complex operations and manage financial resources effectively, with expertise in change management and innovation
- Exceptional communication skills and a genuine commitment to collaboration and comprehensive patient care

## Compensation and Benefits

- Base salary range: \$165,000–\$265,000 for Professor, \$135,000–\$225,000 for Associate Professor, plus additional compensation for service as Chair (per NYC Pay Transparency Act).
